



# Hello Neighbour,

Welcome to the community newsletter from McGee. We are carrying out the demolition and façade retention phase for the North and South blocks as part of the South Molton development, on behalf of Grosvenor and Mitsui Fudosan.

## Progress so far.

- The deconstruction and demolition works of the Portland stone façade at 56 Davies Street have been completed down to level 1.
- The demolition of 48-58 Brook Street has been completed down to level 1, and weather protection installation is underway.
- Brookfield House's facade deconstruction is also completed, and all stone has been transferred off-site.
- The piling enabling works have been finished, including obstruction removal, and phase 2 has started.
- Underpinning works have also commenced around the site.

#### Planned works for this month.

- Completion of demolition at 56 Davies Street and 48-58 Brook Street.
- Piling will continue for the next three months.
- Scaffolding will be removed in line with any demolition.
- Installation of façade retention structure to 52-54 Davies Street.




#### Noise, Vibration and Dust (NVD).

We will make every effort to minimise noise, vibration, and dust during the construction works. To achieve this, we have set up NVD monitoring equipment at sensitive receptor locations around the site. The monitoring will ensure that the work complies with the agreed NVD levels outlined in the Westminster Council Code of Construction Practice 2022 and statutory guidelines.

We have voluntarily entered into an S61 agreement with Westminster City Council, which binds us to the following commitments:

- Completing our works using the latest industry machinery and best practice methods
- Implementing a process to monitor noise, dust, and vibration around the site
- Restricting our noisy working hours to minimise the impact on our neighbours

# South Molton Street

# Dear Neighbours,

Curo Construction have now begun early works on the South Molton Street development, marking the start of the regeneration of heritage buildings along the street. Over the coming weeks the following activities will be taking place as we mobilise on site:


- Phased installation of hoarding South Molton Street and South Molton Lane.
- Commencement of underpinning works with internal demolition of basements.
- Façade repair and cleaning to South Molton Street/Lane.
- Strip out demolition works starting in 42 South Molton Street.
- Staircase alteration and repair within 18 South Molton Street.

#### **Site logistics**

South Molton Lane is now closed and will remain closed for the duration of the project. South Molton Passage which links the Lane to the Street (near 23 SMS) will remain open throughout our works and be fully accessible to the public.

The Hoarding will be erected in phases over the month of May. The map opposite shows the order of the phasing of these works. The duration of the works will be four weeks in total and will completely encase units 15-25 South Molton Street and South Molton Lane.

All deliveries will enter the project via brook street and use the small in road on South Molton lane as a turning circle for traffic.
